1. CALL TO ORDER

The meeting was called to order by Mayor Blackler at 7:05 pm.

3. APPROVAL OF AGENDA

Motion #23-011: Moved by Councillor Barnes and seconded by Deputy Mayor Greenham to purchase a new condenser for the arena at a quoted cost of \$80,227.60. All in Favor (6/0). Motion carried.

Mayor Blackler advised that the Physician Retention and Recruitment Committee is arranging a time to meet. Leanne Hann updated Council on the Wendall Clarke Game. Leanne Hann updated Council on the Dental Benefits plan for the Town.

A. Finance Committee

Town Bills

Motion #23-013: Moved by Councillor Watkins and seconded by Councillor Barnes to approve payment of Town bills as presented during the committee meeting on February 13, 2023. All in Favor (6/0). Motion carried.

Pumphouse

Councillor Watkins advised Council they will need to look at creative ways to finance the pump house project.

Rockcut

Councillor Watkins advised that the Rockcut account was not included in previous Town financial audits, however it will be moving forward.

81 Durrell Street / 16 Minty's Farm Road

Resident complaint regarding increase in land tax. Committee recommends discounts not be granted. CAO to advise resident accordingly.

39 Slades Lane

158 Main Street Land Donation

TITA Visitor Information Centre Proposal

A proposal submitted by TITA to Council for operating of the Visitor Information Centre for the 2023 Season was discussed.

Resident request for variance on land size. Council requested all available historical information on-file for the property be presented for further consideration.
