- A. Public Works

Following a thorough evaluation process, it was confirmed that all Councillors and the Mayor have reviewed, discussed and evaluated the six (6) proposals received for the development of the Town's new Municipal Plan and Development Regulations. The final evaluation sheet was distributed and all Councillors agreed that it accurately reflects their evaluation.

It was agreed that the Committee would recommend to Council that the contract be awarded to Upland.

7. CORRESPONDENCE

Motion #19-48

Correspondence from a local seasonal resident requesting a special rate of taxation for property owners who use their property minimally each year was tabled for discussion. The Town Clerk/Manager clarified that our current policy does not allow for discounts for seasonal residents. It was further noted that with respect to our water/sewer, the rate/fee is based on access rather than consumption. With respect to garbage pick-up, the Town is charged \$81/year by Central Newfoundland Waste Management for each home, whether it is occupied or not. It was moved by Councillor Barnes, seconded by Councillor Hynes, not to introduce a reduced taxation rate for seasonal residents.

Motion #19-49

It was moved by Councillor Greenham, seconded by Deputy Mayor Dalley, to approve a request to operate a two (2) bedroom apartment and a one (1) bedroom seasonal nightly rental at 183 Main Street. As this property is within a Mixed Development zone, this approval is subject to advertising and the applicant's compliance with all Municipal, Provincial and Federal Regulations.

A resident expressed interest in purchasing a property that is in arrears. Although the property is in disrepair, he is willing to take it over if a portion of the outstanding taxes are written off. It was moved by Deputy Mayor Dalley, seconded by Councillor Hynes, to grant the request as a means of bringing this property out of arrears and paying taxes.

10. GENERAL BUSINESS

The Town Clerk/Manager shared with Council that she is in receipt of a Crown Lands Referral for Twillingate & Beyond to infill the shoreline at 94/96/98 Main Street in order to create a parking lot. It was moved by Deputy Mayor Dalley, seconded by Councillor Blake, to approve the referral.

The Town Clerk/Manager informed Council that we are still waiting on the Province's approval to proceed with our 2018 MCW Projects (Park Rd. Water & Sewer Extension and Street Paving). The Province has advised that both projects should be approved to go to tender within the next 2 weeks.

Minute 19-58

The Town Clerk/Manager informed Council that applications for Emergency Funding have been submitted for both the brine pump at the stadium and the pump for the Gillesport Road Lift Station.

Minute #19-59

The Town Clerk/Manager informed Council that the oil tank at the Recreation Centre is expiring in July 2019. As per Government Regulations, it will need to be replaced. The Facilities Manager is requesting auotes.

Motion #19-60

It was moved by Councillor Barnes, seconded by Councillor Greenham, to purchase a ½ page ad in the Downhome Explore Travel Guide 2019.

Minute #19-61

The Town Clerk/Manager informed Council that a new closing date of April 15th has been set for the purchase of 25 Toulinquet Street.

Mayor White noted that the Atlantic Canada Initiative has a Communities in Bloom initiative. Mayor White agreed to let TITA know, as TITA ran a Twillingate in Bloom program last year.

Mayor White informed Council that he will be attending a meeting with the Twillingate Public Library and that he plans to invite their representation to a Council Meeting.

Minute #19-64

Councillor Blackler informed Council that a National Lifeguarding Course is now required for students to work as lifeguards at the pool. The Recreation Committee is concerned that students will not be interested in taking this on and therefore we won't be able to staff the pool.

Minute #19-65

Councillor Barnes raised a concern about trash in Minty's Farm. It was agreed that the Town would create a post on Facebook to help address the issue.

Motion #19-66

Councillor Blackler requested that Council support JMOC's Breakfast Program auction. It was moved by Councillor Greenham, seconded by Councillor Barnes, to donate \$200 for the auction.
