5. OTHER MATTERS – DECISION / DIRECTION NOTES

It was raised by Councillor Blake that he received a phone call prior to the meeting from a local business owner who was upset over the timing of an unscheduled water line dig scheduled for August 10<sup>th</sup>, 2021. Based on feedback from business owners and residents during a previous water break and required work - it was determined that commencing work at 8:30am (water shut off) is more acceptable to allow tourists/ residents to prepare for the morning in advance of no water. Much discussion took place including bringing in staff to begin work at 5am / 6am. This may pose more challenges such as delays, noise, safety, and coordinated efforts for outside employers and contactors. Decisions such as this are very operational, and therefore; public works and contractors will take all concerns into consideration prior to scheduling work. Council noted that it would be impossible to accommodate individual business owners based on their specific business needs. Council agreed that infrastructure upgrades and repairs are necessary for the long-term stability of the water system.
