Purpose:

To outline the responsibilities of the Town and/or property owners for collection of Property & Water/Sewer tax.

Authority:

- Council Discretion
- Municipalities Act, Chapter M-24, SNL1999

Collection Procedures

Tax Collection of Property, Water/Sewer – Residential, Commercial & Business

Step 1: Make Telephone Calls

Step 2: Send Statements in Mail (February, June, October)

Step 3: 1st Collection Letter

Send Reminder Letter – 10 days to pay and/or make arrangements.

Step 4: 2nd Collection Letter

Send Demand Letter – 10 days to pay and/or make arrangements.

Step 5: **3**rd **Collection Letter**

Send Final Letter – 7 days to pay and/or make arrangements.

Step 6: Further Action

Water shut off/rental seizure.

Procedure for Making Arrangements:

Meet with taxpayer to discuss situation and agree on a payment plan (weekly, biweekly, monthly). Present payment plan to Council for approval. Upon approval, collect cash, postdated cheques, etc.

Procedure for NSF Cheques:

Contact customer to make arrangements for cash payment. A \$6.50 banking fee will be added to the amount owing. If cash payment is not received within 24 hours, charge customer a \$20 Administration Fee. If balance is still unpaid, send collection letters, and if necessary, take further action as required.
